PROGRESS REPORT ON THE COMMUNITY PLANNING PARTNERSHIPS (CPPs)

1. Purpose

1.1 To advise the Committee on progress in the implementation of the Community Planning Partnerships (CPPs) approved in the first round, and progress in the revision of the two CPP bids which did not meet the quality threshold in the first round.

2. Background

- **2.1** By written procedure, the Committee was advised on the revised allocations to the CPP bids in the first round of the programmes, particularly with regard to ESF Priority 1 Progressing Into Employment. In view of the increased availability of funds and the quality of the plans submitted by the eleven CPPs, Ministers decided to fund all of the ESF activity set out in the original CPP bids considered to be of an acceptable standard. This involved a commitment of up to £37.5m for ESF Priority 1 against a commitment of £13.5m under ERDF Priority 3 Urban Regeneration. The Committee will recall that the CPP bids involve integrated employability, regeneration and enterprise programmes. More fundamentally, the thrust of these programmes have targeted employability measures supported by the ESF with the ERDF component assuming a complementary role in the context of job brokerage and enterprise support.
- As a consequence of the decision of Ministers to fund all of the ESF activity set out in the 2.2 eleven CPP bids, the Cabinet Secretary for Finance and Sustainable Growth, wrote to each CPP lead authority setting out his expectation that this additional investment will result in each CPP proposal delivering outcomes and spend profiles in line with the original applications. Following from this communication from the Cabinet Secretary, additional clauses have been inserted in the offer of grant letters to the individual CPPs. Offer of grant letters are being issued to all CPPs following resolution of outstanding technical issues. These clauses refer to the requirement to meet the European Commission's annual expenditure targets (N+2) and in view of the significant level of resources being allocated to the CPPs the consequential need for the CPPs to spend as proposed within the two year In addition and as highlighted in the Cabinet Secretary's letter, it will be timeframe. important for the CPPs to involve the Third Sector in the delivery of the CPP proposals and for their involvement in discussions on co-ordination with their individual projects. Moreover, where CPPs are using an open and transparent public procurement route to achieve the outcomes envisaged, the CPP should ensure accessibility of this process to the Third Sector.
- **2.3** The Scottish Government is engaged currently in a series of follow-up discussions with individual CPPs on a range of compliance and audit issues. Where generic issues arise these will be disseminated across the relevant CPP population in order that everyone has access to consistent and up to date advice.

- 2.4 In view of the substantial level of European Structural Funds being committed to the CPPs they in common with the other strategic delivery bodies will require to provide financial and physical performance information on a quarterly basis to the IAB in order that the overall performance of the Programme Priorities can be assessed and reported to the Monitoring Committee. This is in addition to the claiming and reporting requirements that follow the introduction of the €UROSYS system. A standard reporting requirement and format has been designed which will apply to the CPPs, the Scottish Enterprise SDB and the South of Scotland Global Grants Body. In addition, and in recognition of the fact that these new strategic bodies will be establishing new internal management arrangements, the Scottish Government will organise a pre-claim systems audit to each body in order to ensure their robustness and ensure that best practice is identified and shared.
- 2.5 In addition, Ministers agreed that all thirteen eligible targeted areas under Priority 1 ESF and Priority 3 ERDF should benefit from European Structural Funding support. Accordingly, the two CPP areas of Clackmannanshire and Inverclyde which did not meet the quality threshold in the first round should re-submit revised and strengthened applications following detailed feedback and advice from the IAB and Scottish Government policy officials.

3. Revised Proposals from Clackmannanshire and Inverclyde

- **3.1** Revised proposals have been received and undergone initial technical checks and scoring. The special Standing Advisory Group for CPPs has been re-convened and met on Tuesday 14 October 2008 to consider the two CPP bids.
- **3.2** The two bids in keeping with the eleven other bids are focussed on targeted Employability measures with ERDF providing complementary job brokerage, ICT infrastructure and incubator accommodation for enterprises and social enterprises. The respective bids are provided below at Table 1.
